### The Details:

A New Member Referral Form must be presented by the new member at the time membership is established to qualify, and it must include the referring member's name, address, and email address.

For both the referring member and the new member to qualify for the \$25 bonus, the new member must open a Regular Share Savings Account and a Checking Account at the time membership is established. Both accounts must remain open and in good standing for a minimum of 60 days.

If the new member has established a direct deposit of at least \$400 per month into their Checking Account within 60 days of opening, the new member will receive a \$75 bonus deposited into their Savings Account instead of the \$25 as described above. If direct deposit is not available through the new member's employer or retirement service, the \$75 bonus may be earned if, within 60 days of account opening, a Term Share Certificate is opened or a new loan is booked with OHecu. If the new loan is a credit card, it must be used within the 60-day period.

Both the referring member and the new member must be in good standing at the time the bonus is deposited.

Bonus deposits will be made only after the new accounts have been open for a minimum of 60 days.

\*OHecu employees, committee members, directors and family thereof are not eligible for this offer. Any referring member who receives \$600 or more in referral bonuses in any calendar year will be issued a 1099 Miscellaneous Statement for tax reporting purposes. The amount of the referral bonus given to new members will be included on a 1099 INT for the calendar year in which it was deposited.
